The Arc of Loudoun at Paxton Campus, located on a beautiful 17-acre campus in the heart of Leesburg, is a full-service nonprofit dedicated to providing an integrated and innovative environment for children with disabilities and connecting their families to the resources and support they need. In 2017, The Arc of Loudoun:

- Equipped 58 of our [Open Door Learning Center](#) preschool children with and without disabilities with the social and developmental skills needed to thrive in mainstream kindergarten.
- Challenged 48 students, primarily with autism, at [The Aurora School](#) to achieve personal excellence, gain independence, learn life and vocational skills.
- Opened [Ability Fitness Center](#) for people living with neurological disorders—stroke, brain injury, spinal cord injury, cerebral palsy—giving them a one-of-a-kind place to access specialized equipment and expert clinicians. Additionally, students from The Aurora School strengthen their fine and gross motor skills in a safe, supportive environment.
- Launched [Aurora Behavior Clinic](#) where children with intellectual and development disabilities from the community have a highly-trained team of diagnosticians, Board Certified Behavior Analysts, Occupational and Speech Therapists, and ABA Therapists committed to their success.
- Through [ALLY “A Life Like Yours” Advocacy Center](#), connected 3,100 people with disabilities, their families, caretakers, and the professionals who work with them with the resources they need to live a life like yours.
